ASSISTANCE PROVIDED INCLUDED THE DISTRIBUTION OF 1,017,401 POUNDS OF FOOD AND TOILETRIES VALUED AT \$1,729,581; 90,823 ARTICLES OF CLOTHING VALUED AT \$272,469; FINANCIAL ASSISTANCE OF \$83,908 WAS PAID DIRECTLY TO LANDLORDS AND UTILITY COMPANIES PREVENTING 542 PEOPLE FROM EVICTION OR UTILITY DISCONNECTION.
