THE FARMING AND GARDENING NONPROFIT CURRENTLY MANAGES 22 FARMS, COMMUNITY GARDENS, AND SCHOOL GARDENS THROUGHOUT MISSOULA, MONTANA. ITS MISSION IS ENACTED THROUGH FOUR PROGRAMS ON WHICH MORE THAN 20,000 COMMUNITY MEMBERS RELY EACH YEAR.

THE COMMUNITY GARDENS PROGRAM OFFERS PEOPLE THE OPPORTUNITY TO AFFORDABLY GROW FOOD TO FEED THEIR OWN FAMILIES. ROUGHLY 65% OF PARTICIPANTS LIVE IN LOW-INCOME HOUSEHOLDS WHERE BUDGETS ARE TIGHT. 
