North Valley Food Bank (NVFB) builds food security and strengthens communities. NVFB served more than 1,200 neighbors each week in 2025 through our Free Grocery Store in Whitefish, and Mobile Pantries in Trego, Olney, and Essex. Additionally, NVFB delivers commodity and rescue food to seven partner pantries across Northwest Montana. We distributed hundreds of thousands of pounds of fresh, nutritious food and offered customers a dignified, no-barrier shopping experience.

Highlights in this fiscal year include:

Between July of 2024 and June of 2025, NVFB facilitated 23,700 food bank visits - an all-time high for our organization.

NVFB grew our Farm to Food Bank Program and partnered with local farms to rescue and glean 11,500 pounds of surplus produce and purchased over 41,000 pounds of seasonal crops.

NVFB Culinary Arts Manager and volunteers transformed rescued and local food into 12,680 ready-to-(h)eat meals for older adults, families, and neighbors without kitchens, providing nourishment during uncertain times.

NVFB rescued over 200,000 pounds of high-quality food from grocery stores and local businesses, keeping food out of landfills.

NVFB serves on the Montana Food Pantry Collaborative Steering Committee, collaboratively advocated for the protection of SNAP benefits, and helped reinstate Summer EBT for children.
