THE LARGE AMOUNT OF FUNDING WE RECEIVED THROUGH GRANTS ALLOWED US TO INCREASE OUR STAFF CAPACITY, WITH ABOUT TWO THIRDS OF OUR \$187,293 IN TOTAL EXPENDITURES GOING TOWARDS PAYMENTS FOR INDEPENDENT CONTRACTORS. OTHER EXPENSES INCLUDED PROFESSIONAL FEES FOR CONTRACTORS, ADMINISTRATIVE COSTS, AND TRAVEL.
