MORE THAN 74% OF MONTCLAIR RESIDENTS HAVE A LIBRARY CARD, AND THE FOUNDATION SUPPORTS PROGRAMS AND SERVICES THAT BENEFIT THE WHOLE COMMUNITY. WHILE MUNICIPAL FUNDING PROVIDES FOR BASIC LIBRARY SERVICES (STAFFING, UTILITIES, BUILDING MAINTENANCE, ETC.), THE FOUNDATION SUPPORTS PROGRAMMING AND SPECIAL PROJECTS THAT MAKE OUR PUBLIC LIBRARY TRULY UNIQUE. FROM EARLY CHILDHOOD LITERACY TO PROGRAMS FOR SENIORS, THE FOUNDATION HELPS EXPAND THE LIBRARY'S REACH AND PROVIDES NEEDED SERVICES TO THE PEOPLE IN OUR COMMUNITY.

THE FOUNDATION SUPPORTED THE EXPANSION OF THE LIBRARY OF THINGS, ALLOWING LIBRARY PATRONS TO BORROW ITEMS SUCH AS TOOLS, BOARD GAMES, AND MUSICAL INSTRUMENTS. FUNDING FROM THE FOUNDATION ENABLED THE LIBRARY TO OFFER EXPANDED ACCESS TO DIGITAL RESOURCES SUCH AS HOOPLA AND KANOPY AS WELL AS RESEARCH TOOLS LIKE THE EBSCO BUNDLE, FREE TO ALL LIBRARY CARD HOLDERS. IN ADDITION, FOUNDATION SUPPORT PROVIDED START-UP FUNDS FOR AN OUTDOOR SUMMER STORY WALK PROGRAM AS WELL AS ADDITIONAL DECODABLE BOOKS FOR THE CHILDREN'S COLLECTION.

THE ROTATING INVENTORY IN THE BOOKMOBILE, AND THE HARDWARE AND SOFTWARE THAT MAKE IT POSSIBLE TO BORROW BOOKS AND OTHER MATERIALS AND ISSUE LIBRARY CARDS, IS SUPPORTED BY THE FOUNDATION.
