WE HAVE ALSO ASKED AND RECEIVED ADDITIONAL STATUS UPDATES FROM OUR PARTNERS, INCLUDING PHOTOS AND VIDEOS, TO CONFIRM APPROPRIATE USE OF FUNDS. AS OF FILING, WE HAVE NOT IDENTIFIED ANY MISUSED FUNDS THROUGH THESE COMPENSATING CONTROLS AND LOOK FORWARD TO RETURNING TO HAITI WHEN SAFE.
