Saavi Services for the Blind, a Certified Structured Discovery Training Center through the NBPCP, believes in a world where blind individuals are equal contributors locally, nationally, and globally, demonstrating it's not what you can see but what you can do. We teach alternative skills of blindness, enabling individuals to succeed in their goals. Emphasizing strategic problem-solving and fostering positive attitudes to boost confidence and self-efficacy.

Providing Training to over 2,000 students of all ages, Saavi Services for the blind:

- Provides mentorship to new parents of blind children by connecting them with our blind role models, and the Arizona Organization of Parents of Blind Children, a division of the National Federation of the Blind.
 - offer age-appropriate children and youth opportunities to over 250 families in Arizona including
 - After school tutoring to support learning gaps from the pandemic, to support schools with alleviating accommodation gaps that may occur with homework assignments, and to support parents in learning alternative skills and strategies when working with their blind children.
 - Saavi Saturdays to learn the alternative skills of everyday life including independent travel, age-appropriate chores, and gaining confidence as strong blind children and youth.
 - Home visits with families to address individual goals related to everyday life.
 - The provision of resources from basic home adaptations to technological solutions.
 - Extended School Year summer programs to support schools and students in avoiding learning loss during the summer break.
 - Hosting the NFB Braille Enrichment through Literacy and Learning, BELL academy where students strengthen their blindness skills while gaining friendships and increasing confidence.
 - Ready Set Go transition summer program, designed for high school students in learning blindness skills and academic and job readiness skills to support them when they transition to post-secondary education or employment.

- Provides comprehensive blindness skills training at our training centers and itinerantly across the State of Arizona to hundreds of Blind adults wishing to gain or regain employment. These services include:
 - Readjusting students and their families understanding of the capacity of blind individuals by teaching a positive philosophy about the true potential of blind people. With the right exposure to competent blind role models, skills training, and access to alternative tools and resources, blind people can accomplish their career goals in any career field.
 - Training in the use of the white cane for independent travel through orientation and mobility.
 - Braille instruction.
 - Independent Living Skills training.
 - Access technology training and equipment provision.
 - Academic instruction including GED, English as a Second Language, college preparation, and college tutoring services.
 - Job Readiness instruction and job placement and retention services.

- Independent Living services for older adults to hundreds of blind seniors including,
 - Acquired Skills and Knowledge (ASK) group classes designed to support newly blind seniors in learning about the capacity of blind people and to learn about tools and resources they can use to remain safe and independent in their homes.
 - Individualized training in their homes or in our training centers in the areas of independent living, Braille, independent travel, and technology.
 - Weekly senior support groups and individual counseling.
 - Four yearly senior retreats throughout the state of Arizona to support rural Arizona populations.
