Statement of Program Accomplishments – 2021:

Southern Arizona Association for the Visually Impaired, doing business as Saavi Services for the Blind has a mission to cultivate growth and opportunity for blind people through nonvisual skills and other specialized training; demonstrating that all challenges have solutions and fostering self-efficacy through empowerment and confidence.

Offering Training to over 2,000 students of all ages, Saavi Services for the Blind provides mentorship to new parents of blind children by connecting them with our blind role models, and the Arizona Organization of Parents of Blind Children, a division of the National Federation of the Blind. Saavi Services for the Blind strives to:

1. offer age-appropriate children and youth opportunities to over 250 families in Arizona including after school tutoring to support learning gaps from the pandemic, supports schools with alleviating accommodation gaps that may occur with homework assignments, and support to parents in learning alternative skills and strategies when working with their blind children.
2. Saavi holds 'Saavi Saturdays' for children and youth to learn the alternative skills of every day life including travel, age-appropriate chores, and gaining confidence as strong blind children and youth.
3. Saavi does in-home visits with families to address individual goals related to everyday life. The provision of resources includes from basic home adaptations to technology solutions.
4. Saavi hosts extended school year summer programs and camps to support schools and students to avoid learning loss during the summer break.
5. Saavi hosts the NFB Braille Enrichment through Literacy and Learning, BELL Academy where student strengthens their blindness skills while gaining friendships and increasing confidence.
6. Ready-Set-Go is transition summer program designed for high school students in learning blindness skills and academic and job readiness skills to support themselves when they transition to post-secondary education or employment

Saavi provides comprehensive blindness skills training at our training centers and itinerantly across the State of Arizona to hundreds of Blind adults wishing to gain or regain employment. Services include:

1. Re-adjusting students and family's understanding of the capacity of blind individuals by teaching a positive philosophy about the true potential of blind people. With the right exposure to competent blind role models, skills training, and access to alternative tools and resources, blind people can accomplish their career goals in any career field.
2. Training in the use of the white cane in orientation and mobility training
3. Braille instruction
4. Independent Skills training
5. Access technology training and equipment provision
6. Academic instruction including GD, English as a second Language, college preparation, and college tutoring services.
7. Job readiness instruction and job placement and retention services.

Independent Living services for older adults to hundreds of blind seniors including:
