Opinion

We have audited the accompanying financial statements of Avon Theatre Film Center, Inc. (a non-profit organization), which comprise the statements of financial position as of March 31, 2025 and 2024, and the related statements of activities, functional expenses, and cash flows for the years then ended, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the financial position of Avon Theatre Film Center, Inc. as of March 31, 2025 and 2024, and the changes in its net assets and its cash flows for the years then ended in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Avon Theatre Film Center, Inc. and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Avon Theatre Film Center, Inc.'s ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Auditors' Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Avon Theatre Film Center, Inc.'s internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Avon Theatre Film Center, Inc.'s ability to continue as a going concern for a reasonable period of time.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

Notes to Financial Statements
March 31, 2025 and 2024

1. The Organization and Tax Status

Avon Theatre Film Center, Inc. (the "Center") is a non-profit organization that was incorporated in Delaware on April 16, 2003. The Center promotes and fosters a public appreciation of the cinematic arts, including the exhibition of educational films and films of independent and/or emerging filmmakers.

The Center is exempt from income taxes under Section 501(c)(3) of the Internal Revenue Code.

2. Summary of Significant Accounting Policies

Basis of Presentation

The financial statements are prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP"). Net assets and revenues, gains and losses are classified based on the existence or absence of donor-imposed restrictions. Accordingly, the Center's net assets are classified as net assets with donor restrictions and net assets without donor restrictions.

Net Assets

Net assets, revenues, gains, and losses are classified based on the existence or absence of donor or grantor imposed restrictions. Accordingly, net assets and changes therein are classified and reported as follows:

Net Assets without Donor Restrictions – Net assets available for use in general operations and not subject to donor or certain grantor restrictions.

Net Assets with Donor Restrictions – Net assets subject to donor-imposed or certain grantor-imposed restrictions. Some donor-imposed restrictions are temporary in nature, such as those that will be met by the passage of time or other events specified by the donor. Contributions restricted by donors are reported as an increase in net assets without donor restrictions if the restrictions expire (that is, when a stipulated time restriction ends or purpose restriction is accomplished) in the reporting period in which the revenue is recognized. All other donor-restricted contributions are reported as an increase in net assets with donor restrictions, depending on the nature of the restrictions. When a restriction expires, net assets with donor restrictions are reclassified to net assets without donor restrictions and reported in the statements of activities as net assets released from restrictions.

Estimates

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Significant estimates include net realizable revenue, net present value of right-of-use asset and right-of-use liability, net present value discount of long-term pledge receivables, the allowance for doubtful contributions receivable, and depreciation and amortization expense. Actual results could differ from those estimates.

Cash and Cash Equivalents

Cash equivalents consist of short-term highly liquid investments, with maturities of three months or less at the time of purchase.

Allowance for Contributions Receivable

An allowance for uncollectible contributions receivable is estimated based on a combination of write-off history, aging analysis and any specifically known troubled accounts. Management has concluded that an allowance is not required at March 31, 2025 and 2024.

Inventory

Inventory consists of concession products and supplies and is valued at lower of cost (first-in, first-out) or net realizable value.

Property, Equipment and Depreciation and Amortization

Property and equipment are recorded at cost, or if received by donation, at estimated fair value at the time such items are received. Depreciation is provided using the straight-line method over estimated useful lives, which range from three to thirty-nine years. Expenditures for maintenance and repairs are expensed as incurred. Expenditures that improve or extend the estimated useful lives are capitalized. Leasehold improvements are amortized over the lesser of the useful life of the asset or the term of the lease. Software is also amortized over its useful life.

Contributions

Contributions are recognized when the donor makes a promise to give to the Center that is, in substance, unconditional. Contributions that are restricted by the donor are reported as increases in net assets without donor restrictions if the restrictions expire in the fiscal year in which the contributions are recognized. All other donor-restricted contributions are reported as increases in net assets with donor restrictions depending on the nature of the restrictions. When a restriction expires, net assets with donor restrictions are reclassified to net assets without donor restrictions.

Contributed Goods, Services and Use of Donated Facilities

Donated theatre building and land, furniture and equipment for the new office space, and collection items are included in the financial statements as in-kind revenue in the statements of activities. Donated goods and services related to the Gala are included in the financial statements as special event donations along with the corresponding expenses. Donated legal services are included in the financial statements as in-kind revenue with the corresponding professional services expense in the accompanying statements of functions expenses. An in-kind contribution for a donated facility for administrative office space is reflected within revenue in the accompanying statements of activities along with the corresponding occupancy expense in the statements of functional expenses.

Contributed Goods, Services and Use of Donated Facilities (continued)

A substantial number of volunteers have contributed their time to the Center's program and supporting services. These services did not meet the criteria for recognition in the financial statements.

Revenue Recognition

The Center recognizes revenue in an amount that reflects the consideration that is expected to be received for goods or services when its performance obligations are satisfied by transferring control of those promised goods or services to its members and customers.

Revenue from membership dues and assessments is recognized in the month earned. Membership dues received in advance are included in deferred revenue and recognized as revenue ratably over the appropriate period.

Revenue from Center operations, ticket and concession sales, and other operating activities fees are generally recognized at a point in time which is at the time of sale, when services are rendered and collection is reasonably assured.

Operating Measure

The statements of activities separately report changes in net assets from operating and non-operating activities. Operating activities consist principally of revenues and expenses related to ongoing activities. Non-operating activities for the years ended March 31, 2025 and 2024 consisted of interest and dividend income on cash equivalents.

Functional Expenses

The financial statements report certain categories of expenses that are attributable to more than one program or supporting function. Therefore, expenses require allocation on a reasonable basis that is consistently applied. Occupancy expense is allocated based on each program's share of the square footage of the Center. The remaining expenses that are allocated include salaries and related expenses, professional fees, supplies, meetings and travel, depreciation, insurance, printing and postage, and other administrative expenses which are allocated on the basis of employee time and effort spent on each functional area.

Advertising Costs

Advertising costs are expensed when incurred. Advertising costs for the years ended March 31, 2025 and 2024 were \$25,406 and \$14,981.

Accounting for Uncertainty in Income Taxes

The Center recognizes the effect of income tax positions only if those positions are more likely than not to be sustained. Management has determined that the Center had no uncertain tax positions that would require financial statement recognition or disclosure. The Center is no longer subject to examinations by the applicable taxing jurisdictions for periods prior to 2022.

Subsequent Events Evaluation by Management

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is November 5, 2025.

3. Liquidity and Availability

The following reflects the Center's available financial assets, reduced by amounts not available for general use within one year. Amounts not available for use within one year include financial assets received with donor restrictions that are designated for a specific purpose, timeline or contractual obligation, and have been earmarked as resources available for future years. Total financial assets available to meet cash needs for general expenditure within one year at March 31, are as follows:

*For March 30, 2025, the amount includes all but \$4,860 of contributions receivable as the majority of contributions receivable consists of amounts due for the capital campaign and excludes the expended portion of funds that are with donor restriction until placed into service (see Note 8).

The principal source of liquidity is cash flow generated from contributions and member dues. As part of the Center's liquidity strategy, management structures its financial assets, consisting of cash and receivables to be available as its general expenditures, liabilities and obligations come due within one year.

4. Concentrations

Financial instruments that potentially subject the Center to concentrations of credit risk consist principally of cash, cash equivalents, and cash held for capital improvements. The Center places their cash and cash equivalents with various financial institutions and limits the amount of credit exposure by any single financial institution. Deposits held at financial institutions insured by the Federal Deposit Insurance Corporation ("FDIC") up to \$250,000. At times, the cash balance may be in excess of the FDIC limit. Amounts in excess of FDIC insurance totaled approximately \$3,884,000 and \$731,000 as of March 31, 2025 and 2024.

4. Concentrations (*continued*)

At March 31, 2025 and 2024, 38% and 58% of contributions receivable was from one donor, who is a related party. At March 31, 2025 and 2024, 9% and 10% of contributions receivable was from Board Members. For the years ended March 31, 2025 and 2024, 18% and 81% of contribution revenue were from one donor, who is a related party.

5. Property and Equipment

Included in property and equipment are improvements to the building in which the theatre operates. The following is a summary of property and equipment at March 31:

6. Economic Injury Disaster Loan

The Center applied for and received a Small Business Administration ("SBA") Economic Injury Disaster Loan ("EIDL") in the amount of \$150,000 on August 30, 2020. The note is secured by a security interest in substantially all assets of the Center. The EIDL was modified on August 17, 2021, and the Center received an additional \$49,000. The loan is payable in equal monthly installments of \$889 including interest at a rate of 2.75%. Interest will accrue annually. For the years ended March 31, 2025 and 2024, accrued interest of \$0 and \$5,918 is included in accounts payable and accrued expenses on the statements of financial position. Effective March 2021, the SBA announced extended deferment periods for all disaster loans from 12 months to 24 months. Then, effective March 2022, the SBA granted an additional six-month deferment of principal and interest payments. The first installment, which includes interest only, was due in March 2023. The loan matures in September 2051.

9. Capital Campaign

The Center is undertaking a capital campaign to raise funds to bring its 1939 historic building into the 21st century. The goal of the campaign is to modernize the interior of the building including adding a third auditorium and other facility and equipment upgrades. The funds will also go toward exterior renovations and modernization. The funds will be predominately used directly on these capital related expenditures, as well as on management oversight of the capital campaign.

The members of the board of directors started the campaign off with initial cash contributions totaling \$100,000 during the year ended March 31, 2023. As of the years ended March 31, 2025 and 2024, cash collected and available for capital campaign expenditures is \$3,416,335 and \$625,691. The gross amount raised for the capital campaign as of March 31, 2025 and 2024 is \$7,780,284 and \$2,370,403.

10. Related Party Transactions

For the years ended March 31, 2025 and 2024, the Center recorded contributions totaling \$537,823 and \$2,489,398 from a private foundation controlled by the President of the Center.

For the years ended March 31, 2025 and 2024, approximately 41% and 55% of the Center's total support and revenue came from related parties.

On April 16, 2003, the Center entered into a lease agreement with Avon Theatre, LLC (the "Company"), a Connecticut limited liability company. The sole member of the Company is the Director and the President of the Center. The Company provides the Center with a theatre in Stamford, Connecticut for its film screenings for an annual rent of \$10. The lease expired on December 1, 2023. The Center recognized \$0 and \$24,750 in the statements of activities as in-kind rental income for the year ended March 31, 2025 and 2024.

11. In-Kind Contributions (*continued*)

The Center recognized contributed nonfinancial assets within revenue, including land, buildings, auction items for the Gala, furniture and equipment, professional services, rent, and art collection items. Unless otherwise noted, contributed nonfinancial assets did not have donor-imposed restrictions.

The contributed Theatre Building and Land represents the appraised Fair Market Value of the property located on 272 Bedford St, Stamford, Connecticut which was donated from the Royce's to the Center in August 2023. The aforementioned property is where the Center runs their operations.

The auction items were donated goods for the Gala event. Auction items consisted of wine and spirit bottles, gift certificates for dinners or events, etc. In-kind professional services (other) consisted of donated advertising services from a local marketing firm for the Gala event. Contributed goods and services have been valued at the estimated cost to purchase such goods and services as provided by the related professionals or vendors. In-kind auction items and professional services (other) are included in special events, net of direct donor benefit expenses in the accompanying statements of activities.

In-kind professional services (legal) consisted of donated legal services related to the real estate transfer described above or for the theatre renovation project. Such professional services were recorded at fair market value and are included in the accompany financial statements as in-kind professional services in the statements of activities with a corresponding expense included in professional services in the accompanying statements of functional expenses or were capitalized to construction in progress to the extent they were directly related to construction costs for the theatre renovation project.

Donated furniture and equipment, and collection items were recorded at the fair market value of similar items available from retail sources.

Use of facilities consists of donated office space that the Center used for eight out of twelve months during the year ended March 31, 2024, before the Center entered into their new lease at the Stamford Town Center in December 2023.

12. Operating Lease

In December 2023, the Center leased office space in Stamford, Connecticut. For the years ended March 31, 2025 and 2024, the leases are presented as an operating lease right-of-use ("ROU") asset and operating lease liability of the Center's statements of financial position.

The operating lease ROU asset represents the Center's right to control the use of the underlying asset for the lease term and the lease liability represents the Center's obligation to make lease payments arising from the lease. The operating lease ROU asset and related liability are recognized at the lease commencement date based on the present value of future lease payments. If available, the Center uses the rate implicit in the lease to discount lease payments to present value; however, the Centers current lease does not provide a readily determinable implicit rate. Therefore, the Center has elected not to discount lease payments based on an estimate of its incremental borrowing rate.

The Center has made an accounting policy election to use the risk-free rate in lieu of its incremental borrowing rate to discount future lease payments. In addition to monthly rental charges, the Center is required to pay certain maintenance and utility charges during the term of the lease
