All medical and dental services at the Clinic were done at zero cost to the client. This includes things like STI, hepatitis, HIV screening and treatment, dental preventive and acute care, UTI testing and treatment, and TB testing. The Clinic served 2007 clients and 3,153 encounters with these services. Additionally, the Clinic provided local community referrals via our help desk, social assistance enrollment, homeless community outreach, and peer-to-peer counseling.

The BCHP is a collective organization in which every member (volunteer and paid) has an equal amount of interest in clinic wide decisions. The BoD advises the Clinic, but cannot pass or execute any actions that affect anything more than the Board itself. Instead, meetings called All Clinic Collective Meetings (ACCMs) are held at least quarterly in which all members are invited to attend and can vote to pass motions. There is also a smaller group called the Clinic Steering Committee (CSC), comprised of a representative of each section, that meets twice a month and has some level of authority delegated to it (each sections votes on one of its members to represent the section and vote at meetings).

Form 990, Part VI, Line 7a - How Members or Shareholders Elect Governing Body

The Berkeley Free Clinic operates as a collective in which all members have voting rights on all significant decisions. Members may only vote after having been themselves voted in as members for at least 2 months.

Any decision affecting the Clinic as a whole must be passed at an All Clinic Community Meeting. The members are the governing body.
