THE SCV FOOD PANTRY USES FOOD DONATIONS FROM THE COMMUNITY TO PROVIDE SUPPLEMENTAL FOOD ON A SHORT-TERM BASIS TO QUALIFIED LOCAL RESIDENTS. THE FOOD PANTRY DISTRIBUTES FOOD TO OVER 3,000 INDIVIDUALS, OF WHOM APPROXIMATELY 50% ARE CHILDREN. THE PANTRY RECEIVES A SIGNIFICANT AMOUNT OF DONATED SERVICES FROM UNPAID VOLUNTEERS WHO ASSIST IN PROGRAM SERVICES AND FUNDRAISING.
