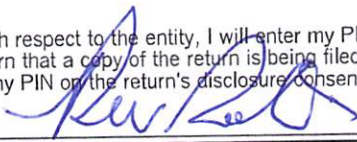

Voting members elect the governing Board of Directors. In addition, the voting members approve the annual budget and all other significant decisions of the Board.
