1. EACH VOTING MEMBER OF THE GOVERNING BOARD, OFFICER, AND EMPLOYEE WILL BE REQUIRED TO COMPLETE A SEPARATE CONFLICT OF INTEREST QUESTIONNAIRE ANNUALLY.

2. A WRITTEN RECORD ON ANY REPORT OF POSSIBLE CONFLICT AND OF ANY ADJUSTMENTS MADE TO AVOID POSSIBLE CONFLICTS OF INTEREST SHALL BE KEPT BY THE PRESIDENT & CEO, OR BOARD CHAIR.

3. THE MINUTES OF THE GOVERNING BOARD AND ALL COMMITTEES WITH BOARD DELEGATED POWERS SHOULD CONTAIN:

A.
