THE COUNCIL CONTINUED TO OFFER HIGH-QUALITY TRAINING FOR EARLY CHILDHOOD PROFESSIONALS, WITH A REMARKABLE 70% SURGE IN PARTICIPATION OF PROFESSIONAL DEVELOPMENT TRAININGS COMPARED TO THE PREVIOUS FISCAL YEAR. THIS GROWTH REFLECTS THE INCREASING DEMAND FOR PROFESSIONAL DEVELOPMENT OPPORTUNITIES AMONG ECE PROVIDERS AND UNDERSCORES THE VALUE OF THE COUNCIL'S OFFERINGS IN STRENGTHENING THE EARLY CHILDHOOD WORKFORCE. THE INTRODUCTION OF TRAINING PROGRAMS IN ADDITIONAL LANGUAGES, SUCH AS DARI AND FARSI, CONTRIBUTED TO AN 85% INCREASE IN NON-ENGLISH TRAINING SESSIONS, BROADENING THE REACH OF OUR SERVICES TO A MORE DIVERSE GROUP OF ECE PROFESSIONALS
