In 2021, some educational groups were able to make in-person visits to Loko Ea for our aina based curricula focused on fishpond ecology, fishpond traditions, and natural resource management. Student groups continued to engage in both virtual and hands-on learning experiences for students ranging from pre-K to university levels. We continued to provide lessons and planting kits for students who visited Loko Ea both online and in-person.

Kulaiwi Nani Restoration Overview: Malama Loko Ea Foundation (MLEF) restarted in-person community workdays with limited group capacities, adhering to CDC safety guidelines for Covid.
