Women's Empowerment & Entrepreneurship Program Houston (WEPH) – with Impact Houston Graduated 29 Spanish-speaking immigrant women entrepreneurs from the 2025 cohort – the program's largest to date – through a curriculum delivered entirely in Spanish using a trauma-informed, human-centered design methodology covering micro-entrepreneurship, business planning, financial literacy, creativity, and leadership. Building on the 2024 pilot, the Personalized Business Mentorship Program supported 11 graduates with a combined 420 hours of one-on-one mentorship over four months, helping each woman grow her business and strengthen her role as a leader and supporter of other women in her community. Funded in substantial part by a \$60,000 grant from Impact Hub Houston.

Water4All with QBL & Rotary GG#2681765 – Bolivia Launched the preparation phase of Rotary International Global Grant GG#2681765 with Quaker Bolivia Link, conducting a comprehensive WhatsApp-based baseline household survey in the Indigenous communities of Chijchi Baja and Collpa Belén – reaching [# households] – to establish water access, health, and sanitation conditions and to inform the design of the gravity-fed safe-water systems the grant will construct. Developed community education materials in Spanish and Aymara and strengthened local water committees in preparation for construction and long-term community-led maintenance.

Empowering Aboriginal Entrepreneurs – Argentina Through the Digital Business Network for Aboriginal Entrepreneurs, 27 additional Aboriginal entrepreneurs completed targeted business training in 2025, strengthening business skills and expanding professional networks, with most participants engaged in community-based rural tourism ventures alongside gastronomy, traditional crafts, and agroecology. Graduates earned digital certificates issued by the National University of Jujuy, validating their skills and opening new market opportunities.
