The Lift Garage provided low-cost car repairs for Minnesotans who met the
150% Federal Poverty Guideline. During the current year, The
Lift Garage repaired 1371 cars saving their customers \$497,705 in car
repair costs as compared to purchasing those repairs at current
market rates. In addition, free inspections were completed on 122 cars
receiving advice not to spend money to repair the vehicle as the repair
outweighed the value of the vehicle and therefore, saving repair costs. Pre-purchase
inspections were performed on 45 cars saving \$4,500 in inspection costs.
Express service appointments were performed for 22 cars providing bulbs
at no cost and wiper blades, batteries, and fluid top offs at cost. 24 mobile van inspections were
performed to determine if cars should be brought into the shop for repairs.
