NAMATI'S WORK ENABLES POOR AND UNDERPRIVILEGED PEOPLE TO EXERCISE THEIR LEGAL RIGHTS TO PROTECT AND PROMOTE THEIR SOCIAL, CULTURAL, AND ECONOMIC LIVELIHOODS. OUR ACTIVITIES PRIMARILY CONSIST OF PROVIDING AND TRAINING OTHERS TO PROVIDE LEGAL AID SERVICES. NAMATI INTENDS TO BUILD A GLOBAL NETWORK OF PRACTITIONERS TO FACILITATE THE SHARING OF TOOLS AND RESOURCES, FOSTER DIALOGUE, AND ULTIMATELY CREATE A MOVEMENT FOR LEGAL EMPOWERMENT WORLDWIDE.

LAND, ENVIRONMENT, AND CLIMATE (LEC)KENYA: IN KENYA, NAMATI AND ITS PARTNERS WORKED WITH 4 NEW COMMUNITIES AND CONTINUED SUPPORTING 33 EXISTING COMMUNITIES TO STRENGTHEN COMMUNITY-LED GOVERNANCE OF LAND. NAMATI LED MEETINGS TO BUILD AWARENESS AMONG COMMUNITY MEMBERS, SUPPORTED PARTNERS IN RECRUITING NEW PARALEGALS, AND CONVENED PARTNER SETTINGS TO TRAIN AND EQUIP PARALEGALS WITH THE NECESSARY INFORMATION AND SKILLS TO WORK IN THEIR COMMUNITIES. OF THE COMMUNITIES WITH EXISTING SUPPORT, 9 COMMUNITIES ELECTED COMMUNITY LAND MANAGEMENT COMMITTEES (CLMCS) AND REVISED THEIR BYLAWS. IN 2024, NAMATI TRANSITIONED FROM ITS PREVIOUS PARTNERSHIP WITH SAMBURU WOMEN'S TRUST (SWT) AND BEGAN A NEW PARTNERSHIP WITH A LOCAL ORGANIZATION, THE PASTORALIST WOMEN HEALTH AND EDUCATION (PWHE).SIERRA LEONE: NAMATI PARALEGALS IN SIERRA LEONE ACHIEVED REMEDIES TO 11 LAND AND ENVIRONMENTAL JUSTICE (LEJ) VIOLATIONS AND WORKED TO PROMOTE NON-EXPLOITATIVE AND SUSTAINABLE ALTERNATIVE INVESTMENT MODELS (AIMS) ACROSS 3 CARBON PROJECTS. COLLECTIVELY, THESE REMEDIES POSITIVELY AFFECT THE LIVES OF OVER 50,000 PEOPLE AND PROTECT AT LEAST 41,797 HECTARES OF LAND. REMEDIES INCLUDED REVIEWING LEASE AGREEMENTS ACROSS AGROFORESTRY AND LITHIUM MINE PROJECTS, ENSURING THEY ALIGN WITH THE CUSTOMARY LAND RIGHTS ACT (CLRA) ON THE DISTRIBUTION OF LEASE RENT AND RENEGOTIATIONS OF RENT AMOUNTS. PARALEGALS WORKED WITH 123 COMMUNITIES TO SHAPE MANGROVE CONSERVATION PLANS AND NEGOTIATE FAIR BENEFIT-SHARING AGREEMENTS, ENSURING CARBON CREDIT REVENUES RETURN TO THE COMMUNITIES. COMMUNITY LEADERS BUILD KNOWLEDGE IN THE CONTENT AND IMPLEMENTATION OF THE CLRA BY WORKING TOGETHER WITH PARALEGALS ON EVIDENCE GATHERING, ADVOCACY, AND ORGANIZING. COMMUNITY MOBILIZERS AND VILLAGE AREA LAND COMMITTEES (VALCS) ARE CONTINUING TO DEEPEN THEIR CAPACITY AND OPPORTUNITIES FOR ORGANIZING, EMPOWERING THEM TO TAKE THE LEAD IN ADDRESSING LAND AND ENVIRONMENTAL PROBLEMS IN THEIR COMMUNITIES. MYANMAR: NAMATI AND PARTNERS CONTINUE TO SECURE MEANINGFUL REMEDIES WITH COMMUNITIES TO LAND RIGHTS VIOLATIONS AND RESEARCH AND DOCUMENT LAND RIGHTS VIOLATIONS AND AREAS FOR CIVIL SOCIETY ENGAGEMENT ON LAND AND ENVIRONMENTAL JUSTICE ISSUES, DESPITE CHALLENGES POLITICAL AND OPERATIONAL DYNAMICS. OVER THE LAST YEAR, NAMATI AND PARTNERS RESOLVED 164 LAND AND ENVIRONMENTAL JUSTICE CASES, POSITIVELY IMPACTING THE LIVES OF OVER 7,000 PEOPLE. THE MAJORITY OF THESE WERE LAND TITLE REGISTRATION AND LOCAL LAND DISPUTE CASES, REFLECTING POLITICAL DYNAMICS AND EXISTING OPPORTUNITIES FOR TRACTION IN LAND JUSTICE CASES. IN ADDITION TO THESE TYPES OF CASES, THE MYANMAR PROGRAM BEGAN TO SHIFT PARALEGAL CASES TO FOCUS ON COMMUNITY LAND PROTECTION EFFORTS. THESE CASES INVOLVE SUPPORTING COMMUNITIES TO DEVELOP INCLUSIVE BYLAWS FOR THEIR LAND, AND SECURE VARIOUS FORMS OF BOTH CUSTOMARY AND FORMAL LEGAL PROTECTIONS OF THEIR COMMUNITY LAND RIGHTS.
