Fellowship program provides resources and tools to high potential, young social entrepreneurs. It is a 15 month program that includes leadership assessment tools, executive coaching services, leadership development planning, annual summit, mentorship, networking opportunities, and staff support services. Since 2013, the organization has supported more than 200 social entrepreneurs in more than 60 countries. These entrepreneurs have accelerated the growth of their enterprises, generating more than 3,700 jobs, fundraising more than USD\$ 133mn in capital for their ventures, and impacting positively more than 11 million lives.

Under that guidance, GGF may recognize the tax benefit from an uncertain taxposition only if it is more likely than not that the tax position will be sustained on examination by taxing authorities based on the technical merits of the position. Examples of tax positions include the tax-exempt status of GGF and various positions related to the potential sources of unrelated business taxable income (UBIT).

The tax benefits recognized in the financial statements from such a position are measured based on the largest benefit that has a greater than 50% likelihood of being realized upon ultimate settlement.
