

PROGRAMS INCLUDE WORKSHOPS, SEMESTER-LONG COURSES, AND IMPROV-INTEGRATED CLASSES IN SOCIAL/EMOTIONAL LEARNING, AND ENGLISH LANGUAGE ARTS. THE YOUTH SERVED REPRESENT DIVERSE ETHNIC AND CULTURAL GROUPS FROM THE METRO DETROIT AREA. MOST ARE CONSIDERED ECONOMICALLY DISADVANTAGED BY FEDERAL POVERTY MEASURES.
