In 2024, the Albert Schweitzer Fellowship graduated 84 Fellows who received training in leadership, the social determinants of health, and project management as they completed projects addressing unmet health needs in the community. These projects were implemented in partnership with 40-plus community agencies in Houston, Galveston, College Station, and Dallas. The Fellows completed 47 different projects addressing issues like food insecurity, safety in the homes of formerly homeless families, and access to healthcare in refugee communities.
