VITA Latino exists to build relationships within the Latinx community, laying foundations which lead to trust-based counseling and easier access to reliable credit union services. VITA Latino has to date served 3,102 individuals with 1,549 filings accounting for \$2,150,508 in refunds, and \$479,050 in tax preparation savings. It has also delivered \$784,176 in federal and state income taxes paid.
