To date, the curriculum is being taught in nearly 3,000 schools in 17 states, impacting approximately 3 million students per year. Each contracted partner school receives an initial five hours of professional learning as intellectual preparation to teach LGBTQ-inclusive, intersectional academic history, civics, and social studies and schools have access to the digital curriculum in perpetuity, as well as ongoing support and additional new content and revisions.
