 Hosted annually since 2017, Future Summit brings together Gen Z and Millennial lawmakers from across the country and across the political spectrum to learn new policy ideas, build new cross-partisan relationships, and invest in their leadership development. In 2024, 74 lawmakers from 33 states participated in the event. Future Summit South replicates the power of this convening on a regional level, driving an organizing model that bridges state-level engagement with nationwide cross-state collaboration. In 2024, 14 legislators representing states in the South converged on Atlanta for the inaugural Summit.

 The Innovation Lab is a cross-partisan hub for policy education and bridge-building that connects young lawmakers with diverse experts on the issues that matter most to their constituents. Through resources like a policy library, live briefings, on-demand expertise, and collaborative working groups, it equips legislators with unbiased ideas and practical tools to be more effective problem-solvers. The Lab also fosters healthy dialogue and innovative thinking, helping emerging leaders advance solutions and rebuild trust in democratic institutions. Through Innovation Fellowships, cross-partisan cohorts of lawmakers dive deeper into complex policy challenges with expert support, research, and a strong peer network to strengthen their impact in state legislatures.

 Future Caucus' State Future Caucus Network is made up of over 1,900 state lawmakers and 36 state chapters, each co-chaired by two bipartisan Gen Z or millennial lawmakers. The Network is dedicated to creating a space for connection, dialogue, and collaborative policymaking. Each caucus advances a bipartisan policy agenda focused on solutions to the challenges facing future generations. Future Caucus also connects state lawmakers to their peers across state lines through both virtual and in-person programming.

 Future Caucus developed a digital leadership curriculum specifically tailored to meet the needs of young legislators. In 2024, Future Caucus also celebrated two generational changemakers, Paris Hilton and Sophia Bush, for their positive leadership.

It also fosters a strong sense of community through networking, mentorship, and camaraderie that extends beyond formal programming.
