IN THEIR EIGHTH ACADEMIC YEAR (2024-2025), LEARNERS MET 90 COMMON CORE STANDARDS, COMPLETED 18 INDIVIDUAL PROJECTS, 12 SMALL GROUP PROJECTS AND 6 SCHOOL-WIDE PROJECTS. THIS IS A 48% INCREASE IN THE NUMBER OF COMMON CORE STANDARDS COMPLETED OVER THE PRIOR YEAR.

THE NEXT ACTIVITY INVOLVED MAKING A SUPERHERO CAPE THAT DISPLAYED THEIR TOP FIVE SUPERPOWERS.

SCHOOL-WIDE PROJECTS INCLUDED CREATING AND PERFORMING IN TWO MUSIC SHOWCASE EVENTS THAT WERE PREPARED WITH THE MUSIC THERAPIST AND PERFORMED FOR PARENTS AND SPECIAL GUESTS. EACH LEARNER PARTICIPATED IN A WAY THAT WORKED BEST FOR THEM. THE LEARNERS WORKED TOGETHER TO CHOOSE A THEME, AND DESIGNED THE PROPS, AND ALL PROMOTIONAL MATERIALS. THE PERFORMANCES INCLUDED SINGING, DANCING, AND PLAYING INSTRUMENTS. LEARNERS ARE ALSO INVOLVED IN COMMUNITY SERVICE ANOTHER GOOD EXAMPLE OF A SCHOOL-WIDE PROJECT. THE HOLIDAY ELVES PROJECT IS OUR HOLIDAY COMMUNITY SERVICE PROJECT AND WAS LED BY THE LEARNER COUNCIL. LEARNERS THEN DELIVERED THE GIFTS TO THE NONPROFIT ORGANIZATION COLLECTING THE GIFTS.

IN THE MAKERSPACE, LEARNERS ARE UTILIZING THEIR TEAMWORK TO SOLVE STEM CHALLENGES THAT REQUIRE PLANNING AND DESIGN. LEARNERS ARE ASKED TO MAKE A PLAN BEFOREHAND (DRAW A PICTURE OF HOW YOU MIGHT BE ABLE TO SOLVE THIS CHALLENGE), LIST MATERIALS NEEDED, IMAGINE HOW TO COMPLETE THE TASK. THEIR UNDERSTANDING OF THE ELIGIBILITY CRITERIA AND BENEFITS AVAILABLE FOR CHILDREN AND YOUNG ADULTS. AND THEY LEARNED STRATEGIES TO ADVOCATE EFFECTIVELY AND HOW TO OVERCOME COMMON BARRIERS WITHIN THESE SYSTEMS TO ENSURE THEIR CHILDREN OR YOUNG ADULTS HAVE ACCESS TO NECESSARY SERVICES.

- THE WORKSHOPS TITLED, SENSORY PROCESSING AND BIG EMOTIONS, SHARE INFORMATION NOT OTHERWISE AVAILABLE IN SOUTHEASTERN WISCONSIN. THIS INFORMATION IS CRITICALLY IMPORTANT TO PARENTS AND CAREGIVERS OF NEURODIVERGENT INDIVIDUALS BECAUSE THEY OFTEN HAVE MULTIPLE DISORDERS AND DELAYS ALONG WITH SENSORY PROCESSING DISORDER. THIS CAN MAKE PARENTING EXTREMELY DIFFICULT AND NOT FIT ANY CONVENTIONAL METHODS AVAILABLE TO PARENTS. THE BIG EMOTIONS SECTION OF THE WORKSHOP INCLUDES INFORMATION ABOUT HOW TO HELP PREVENT OR EASE THEIR CHILD'S SENSORY SYSTEM FROM BEING OVERWHELMED BY PROVIDING SUPPORT BOTH BEFORE AND DURING THE TIME OF OVERWHELM. PARENT FEEDBACK FROM THE WORKSHOPS REINFORCES THE NEED TO HOST MORE OF THEM. ONE MOTHER WHO ATTENDED SHARED:

"EVERYTHING CHANGED AFTER THE WORKSHOP. FOR THE FIRST TIME I LEARNED WHAT SENSORY PROCESSING IS AND HOW AUTISTIC KIDS CAN HAVE SENSORY PROCESSING ISSUES, THAT BEHAVIOR IS COMMUNICATION (NOT DEFIANCE), AND THAT OCCUPATIONAL THERAPY COULD HELP WITH SENSORY INTEGRATION. I ALSO LEARNED ABOUT SOCIAL EMOTIONAL DEVELOPMENT, CO-REGULATION, AND CALMING STRATEGIES TO WORK THROUGH THE MELTDOWNS. ALTOGETHER THIS IS HELPING US BUILD A BRIDGE WITH HER, NOT ONLY TO COMMUNICATE WITH HER AND UNDERSTAND HER BUT FOR HER TO CROSS FROM LONELINESS AND ISOLATION TO CONNECTEDNESS.
