

In Beloved Community's seventh year we supported 65 organizations with ongoing facilitations, trained 438 organizational leaders in operationalizing their commitments to equity for all. 72% of our organizations portfolio, reflecting the growth of our Equity at Work services. We celebrated the following impact and milestones:
1)Awa By Beloved Suite: In FY 24, 28 organizations completed the Equity Audit and 142 employees completed the Equity Lens Map. The work of these leaders impacted 71,996 full-time staff across their respective organizations.
2) Power to Make Change: In FY24, 28 organizations completed the Equity Audit and 142 employees completed the Equity Lens Map. The work of these leaders impacted 71,996 full time staff across their respective organizations.
