DVU LED THE EMERGING LEADERS PROGRAM TO TRAIN SELF-ADVOCATES AND FAMILY MEMBERS, PARTICULARLY PEOPLE OF COLOR, ON LEADERSHIP AND SYSTEMIC ADVOCACY SKILLS.
