Initially, it served as a means to reintegrate veterans by facilitating connections with fellow veterans, providing a crucial human connection to a new community. However, it has since developed into a fully operational coaching program. Now, veterans themselves administer the Trauma Resiliency Protocol (TRP) and Emotions Management Process (EMP) on a peer-to-peer basis. Currently, we have 75 Resilience Coaches spread across 21 states. Remarkably, these peer coaches are just as effective as licensed counselors.

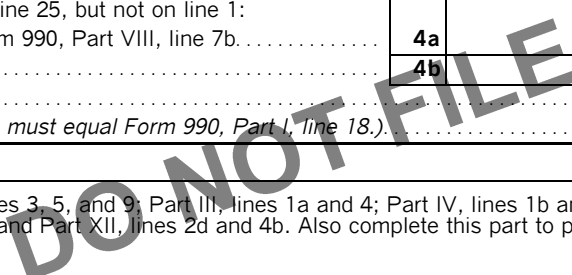

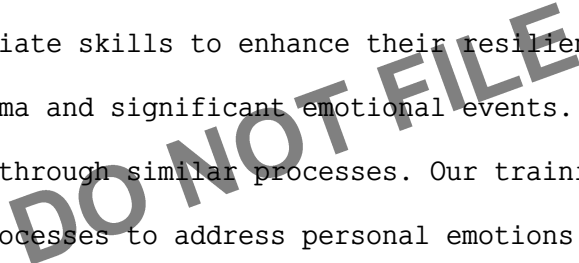
