In-kind contributions in 2024 included Google Ads (\$67,800), office space (\$12,000), Microsoft Azure and Office Suite (\$2,000), Canva Pro (\$300), legal services (\$5,000), Amazon advertising credit (\$1,000), and waived Shopify fees (\$480) While the organization files Form 990-EZ using the cash method and therefore does not report in-kind donations as revenue on Line 1, SAWA SAWA Collection received substantial in-kind support during the year. This included advertising credits from Google (\$67,800), donated warehouse and office space (\$12,000), legal services (\$5,000), software grants, waived fees, and other non-cash contributions totaling \$88,580. These are disclosed here and reflected in Schedule A for public support testing purposes.
