LMA ENTERPRISES: AN ASHER HOUSE EMPLOYEE USED THE INCORRECT LMA CREDIT CARD TO PAY FOR THE ASHER HOUSE PURCHASES, TOTALING \$66,807. WHEN MADE AWARE, THE EMPLOYEE STOPPED USING THIS CARD. THE ASHER HOUSE REIMBURSED LMA ENTERPRISES IN 2023.

THE ASHER HOUSE VEHICLES: THE NON-PROFIT WAS UNABLE TO OBTAIN DIRECT FINANCING DUE TO ITS YOUNG HISTORY. LEE ASHER PERSONALLY GUARANTEED THE FINANCING OF SOME VEHICLES FOR THE ASHER HOUSE.
