College Readiness - The HBCU Bridge - provides college readiness programming for high school students from under-resourced communities, with a focus on increasing access to Historically Black Colleges and Universities (HBCUs). Students participate in structured sessions on HBCU awareness, scholarships, financial literacy, and career exploration, along with experiential learning opportunities. In 2025, the program served approximately 75 students, with the majority applying to and gaining acceptance into HBCUs.

4b (Code:) (Expenses \$ 21,300 including grants of \$ 17,415) (Revenue \$ 10,000)

HBCU Student Scholarships - provides financial assistance to current HBCU students to support college completion and retention. Scholarships help reduce financial barriers and are paid directly to institutions, enabling students to persist and graduate. We provided \$21,300 in scholarships in 2025 and have given \$90,000 since our founding.

Workforce Readiness - HBCU Campus to Career - delivers workforce readiness programming for HBCU students, including career exposure, professional skill-building, and access to industry-recognized certifications. The program connects students to in-demand career pathways and supports successful transitions from college to the workforce.
