What is the organization's primary exempt purpose?
As our world becomes increasingly interconnected and we experience an era of unprecedented world challenges, underserved communities need help overcoming steep barriers to enriching learning opportunities such as international educational travel. Many cannot afford travel costs, unpaid internships, or passport and visa expenses. These disparities reinforce inequities in professional networks, workforce preparedness, and cross-cultural fluency. Without intervention, inequitable access to global exposure perpetuates cycles of limited opportunity. Getaway Growth addresses this gap by providing fully funded, structured, and ethically designed global immersion programs for youth ages 15-24 from historically under-resourced communities.

Getaway Growth's flagship Intercultural Competence program, a 15 day international experiential learning program in Kenya, was held from June 26 to July 14, providing underserved youth with immersive cultural exchange, leadership development, and global education opportunities. The program included 36 hours of historical and cultural exploration, with students engaging directly with local communities, traditions, and educational workshops. The program served 5 students, 3 from the United States and 2 from Kenya, with all expenses fully covered, including travel, accommodation, meals, visas, and full program participation.

Getaway Growth provides structured professional and personal development training, equipping students with skills for academic, career, and leadership success. In 2025, students completed 30 hours of professional and personal development programming, including training in human-centered design, social entrepreneurship, resume building, LinkedIn optimization, networking, and financial literacy. This program emphasized critical thinking, collaboration, communication, and emotional intelligence, enabling students to translate their global experiences into future opportunities. Participants reported significant growth in problem-solving, leadership, and self-awareness, preparing them for college and career pathways while reinforcing their role as global citizens.

Getaway Growth's flagship program additionally focuses on hands-on service learning and community engagement, allowing students to contribute to sustainable local initiatives while learning alongside community partners. Students completed 20 hours of service learning and community impact activities, including environmental conservation efforts, cultural exchange projects, and collaborations with organizations such as A Rocha Kenya and local community groups. Activities included beach cleanups, conservation education, and traditional skill-building exchanges, fostering mutual learning between students and host communities. Through this program, participants developed a deeper understanding of global challenges and their role in addressing them. Notably, 100% of students reported increased empathy and awareness of diverse perspectives following participation.
